The session will explain how to structure each document, frame facts and legal grounds effectively, and ensure evidentiary support through annexures. There will also be guidance on replying to Section 9 petitions, structuring custody and visitation clauses, and avoiding contradictions across multiple pleadings. The workshop is designed to be practical, hands-on, and engaging, enabling participants to draft real legal documents with confidence and precision.
